Council has elected to publish an unaudited version of both of these documents. Our auditors have deferred the audit, because of an auditor shortage in New Zealand as a result of COVID-19 border restrictions. This delay has resulted in the Council being unable to meet its statutory reporting deadline of 31 December 2021. We publish the unaudited documents in the intervening period, to ensure transparency to our community. Actual audited results are likely to vary from the information currently presented and these differences may be significant.
